



IMPORTANT DRONABINOL CAPSULES, USP, 2.5 MG AND ZIPRASIDONE HYDROCHLORIDE CAPSULES, 20 MG RECALL NOTICE

Dear Member,

Your health is important to us. On June 14, 2023 the U.S. Food and Drug Administration (FDA) announced a drug recall notice. This recall is voluntary. It is for specific lots of **Dronabinol Capsules, USP, 2.5 mg and Ziprasidone Hydrochloride Capsules, 20 mg** of The Harvard Drug Group.¹ The FDA issued the recall because of a label mix-up.
